- Company and the Group have followed the same Accounting Policies and methods of computation as disclosed in the Annual Report for the year ended March 31, 2007 and are in compliance with Sri Lanka Accounting Standard - 35, Interim Financial Reporting. Further, new provisions of the new Companies Act No. 7 have been considered in preparing the Interim Financial Statements of the Company and of the Group.
- The Company paid an Interim Dividend of Rs -/125 per share on 20th July 2007.
- Asiri Hospitals PLC together with Asiri Surgical Hospital PLC and Softlogic Holding (Pvt) Ltd acquired 89.28% of the issued and paid up Ordinary Share Capital of Asha Central Hospital PLC. Asiri Hospitals PLC and Asiri Surgical Hospital PLC holds 50.046% and 29.45% respectively as at 30th August 2007. Further, above companies have made a mandatory offer to the rest of the shareholders and acceptance of the offer was received by shareholders representing 9.84% of the issued share capital of Asha Central Hospital PLC. Accordingly the group made the payments to such shareholders.
- There have been no other events, which require disclosure in the Interim Financial Statements.
- All values included in these financial statements are in Rs unless otherwise stated.
